# You must complete, sign and deposit top copy in collection box and display bottom copy on vehicle dashboard before launching your watercraft\*

\*Watercraft means any vessel capable of carrying one or more people on water, including all boats, canoes, kayaks, skiffs and rafts.

 Is your vessel, trailer and all equipment <u>clean</u> of all mud, dirt, plants, fish or animals and <u>drained</u> of all water including all bilge areas, fresh water cooling systems, lower outboard units, ballast tanks, live-wells, buckets, etc. and completely <u>dry</u>?

<u>If you answeredNo</u> to question #1, <u>you MAY NOT LAUNCHyour vessel</u>. Your vessel must be **cleaned**, **drained** and completely **dry** before it will be permitted to launch. Do not clean or drain your vessel by the lake or at the launch ramp. See Question #3 for details on how to properly clean your vessel and equipment prior to launching.

2. <u>If you answered**Yes**</u> to question #1, has your vessel been in any of the infested waters listed on the back page of this form within the last 30 days?

<u>If you answered</u>**No** to question #2, <u>you are ready to launch</u>. Complete, sign and date this Launch Certification Permit and display it on the dashboard of your vehicle.

3. <u>If you answered Yes</u> to question #2, was your vessel, trailer and all equipment thoroughly cleaned and allowed to completely dry for at least 30 days since you last launched or has it been professionally decontaminated? ("Thoroughly cleaned" requires removal of all dirt and organic material, flushing and draining of all live wells, bilge areas, ballast tanks and fresh water cooling systems followed by a 30-day drying period. Professional decontamination requires thorough cleaning and flushing with minimum 140° water and is available at the watercraft inspection station at Alpine Meadows Road and Hwy 89, approx. 12 miles south of Truckee, CA.)

<u>If you answered **Yes**</u> to question #3, <u>you are ready to launch</u>. Complete, sign and date this Launch Certification Permit and display it on the dashboard of your vehicle.

<u>If you answered</u>**No** to question #3, <u>**DO NOTLAUNCH**</u>. Your vessel must be thoroughly cleaned and dried or professionally decontaminated before it will be permitted to launch.
